COVID-19 EMERGENCY RESPONSE - August 23, 2021 REPORT


### KYKOTSMOVI, AZ – August 23, 2021

The information data below can be found on the Hopi Tribe's website "COVID-19 Response and Resources" page.

The Hopi Health Care Center has confirmed through genetic sequencing that the COVID-19 B.1.1.7 Alpha and B.1617.2 Delta variants are within the boundaries of the Hopi Villages and Communities on the reservation.

The Tribe's Department of Health & Human Services and Public Health Authority Royce Jenkins, said "we received a public health notification through state resources reporting SARS Cov-2 Variant confirmed cases of the B.1.1.7 Alpha and B.1617.2 Delta variant. This new variant strain of COVID-19 is more infectious and deadlier. It is likely to have come from individuals that have travelled off reservation. I urge all unvaccinated individuals over the age of 12 to get a COVID-19 vaccine as soon as possible. Acting now could prevent a subsequent surge of infections."

30 samples sequenced to date from positive Cepheid tests collected between 6/18/2021 and 8/9/2021



Those unable to determine have high Ct values, meaning low viral load

Among those able to be sequenced, 92% (22 of 24 samples) are the Delta variant

- Earliest Delta variant collected 6/23/2021
- Since 6/19/2021, all sequenced samples have been Delta variants
- Delta variant has caused cases among the non-vaccinated, partially vaccinated, and fully vaccinated.
- . Both of our two major clusters this summer (i.e., Kiva and Rattlers) both involved Delta variant

Chairman Timothy Nuvangyaoma said, "We must continue to be vigilant, especially given the presence of this new variant. If you have not been vaccinated, you owe it to yourself, your family, your friends and our Tribe to get vaccinated as soon as possible."

The COVID-19 Delta variant B 1617.2 was first identified in December 2020 in India, and the first case in the United States was diagnosed in March of 2021. It is now the most common variant in the United States and accounts for 50% of cases. A recent study shows that the durability of vaccines can provide protection for years, and another study shows that available vaccines do have significant protection against all current variants in the United States, including the Delta variant.

The HHCC has stocked both the Pfizer, Moderna and Johnson & Johnson vaccines. These have been reported as up to 95% effective with mild side effects (pain and swelling at injection site, as well as mild to moderate body aches, low grade fever and chills).

CDC preventive guidelines to follow include:	
Reduce non-essential traveling	Always wash your hands

Hopi Health Care Center – Community Vaccination Information

COVID-19 vaccines are available daily for those 12-years old and older.

Call (928) 737-6049/6081/6148 - Appointments preferred, but not required.

Moenkopi residents Tuba City Regional Health Care will have a Pfizer vaccine community drive-up vaccine clinic now available for individual's 12-years and older. Call 1-866-976-5941 to schedule your appointment.

As of August 23, 2021 the United Sates now has approximately 37,768 million confirmed positive cases over 626,833 deaths reported.

Over 988,714 confirmed positive cases now exist in Arizona. Of those, close to 18,147 are in Navajo and 19,532 in Coconino Counties.

The Hopi Health Care Center has tested over 10,455 patients to date. Over 1,455 of those tests at Hopi Health Care Center came back positive with 1061 from Hopi Tribal members. Tuba City Regional Health Care Corporation reported 277 positives for Hopi Villages with a combined number of 1,339\*\*\* positive Hopi Tribal members.


#### Prevention:

Watch for Symptoms - people with COVID-19 have had a wide range of symptoms reported – ranging from mild symptoms to severe illness. Symptoms may appear 2-10 days after exposure to the virus. Anyone can have mild to severe symptoms. People with these symptoms may have COVID-19:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea


This list does not include all possible symptoms. CDC will continue to update this list as we learn more about COVID-19. Older adults and people who have severe underlying medical conditions like heart or lung disease or diabetes seem to be at higher risk for developing more serious complications from COVID-19 illness.

# **Education:**



This graph demonstrates that cases per day stratified by village with a total case line and rolling seven-day line.

This graph gives the total of positive cases for the day in a blue bar graph. The red line is the moving 7-day incidence average and demonstrates the general trend of Covid-19 of the community.



This graph demonstrates the active cases and is stratified by village. Currently there are 13 active cases that are defined as persons that have had a positive test result or symptom onset in the last 14 days. In this graph, the Total cases bar is all villages combined and should be excluded from the remainder of the graph. This graph is useful in isolating where the virus is most active at the current moment.

This Table looks at both cases per capita for the Tribe and persons that have received at a least one dose of the vaccine since the beginning of the pandemic. The village populations were calculated from the enrolment data from the tribe and is simply a rough estimate.

Total reservation percent vaccinated ~67.92% Eligible population vaccinated \*\* ~75.31%
